#### Dear Valued Residents,

On behalf of Anabuki NL Housing Service Co., Ltd., the Safira Apartment Management Office ("MO") would like to send our warmest greetings and best wishes to all residents.

Pursuant to Notice No. 175/TB-CNTD-KDDVKH dated April 1, 2024 of Thu Duc Water Supply Joint Stock Company on collecting identification codes and reviewing domestic water quotas.

Pursuant to Notice No. 044/2024/TB-SAFIRA dated April 25, 2024 of CBRE Management Office regarding Thu Duc Water Supply Joint Stock Company collecting identification codes and reviewing domestic water quotas.

Up to now, Thu Duc Water Supply Company has received information to update personal identification codes to serve the water norm adjustment of Safira apartment building as follows:

- Total population updated: 21 people
- Total population pending approval: 849 people

This means that from July 1, 2024, cases that have been previously granted norms but have not yet updated will have their water norms adjusted according to the actual records received (cutting previously granted water norms).

In order to ensure the rights of residents of Safira apartment building, the Management Office had a meeting with Thu Duc Water Supply Company to request an extension of the time to update the identification code to review and issue new/adjust the domestic water quota of apartments at Safira apartment building, specifically as follows:

- 1. Time to renew the identification code: From July 30th, 2024 to August 7th, 2024.
- 2. Identification code update profile: Residents please update information showing one of the following forms:
- Citizen identification (correct address of the apartment is granted quota).
- Mẫu 01: Thông báo số định danh cá nhân và Thông tin công dân trong cơ sở dữ liệu quốc gia về dân cư
- Form CT08: Form for notification of settlement results, cancellation of residence registration (for cases where individuals have a residence address different from the address on the citizen identification card).
- Birth certificate: can show personal identification code for children without citizen identification.

#### 3. Implementation methods:

Residents please use your account/password to access the Electronic Information Portal or scan the OR code below to update your personal identification code via a photo of your citizen ID card or form CT08, Form 01, Birth Certificate, etc.
